Original Burger

Hamburger, American cheese, lettuce, tomato, onion, and pickle on a toasted sesame bun with a side salad, side of fruit, and milk

Wyoming Pulled Chicken Sandwich

BBQ pulled chicken, cabbage slaw and red onion, pickles, and sweet and spicy BBQ sauce, on a potato bun, with a side of fruit, and milk

Cobb Salad

Mixed greens, pulled chicken breast, avocado, roasted corn, blue cheese, bacon, tomato, egg, onion straws, and the house vinaigrette, with a roll, side of fruit, and milk

BBQ Ranch Chicken Salad

Mixed greens with tomato, cucumber, avocado, grilled corn, black beans, chicken, and BBQ ranch dressing, with a roll, side of fruit, and milk

Brisket & Grilled Cheese Sandwich

Brisket burnt ends, caramelized onions, arugula, and melted cheddar cheese, on grilled sourdough bread, with a side salad, side of fruit, and milk
